EU: EU Directive site classification based on BOTH *Intestinal Enterococci* and *Escherichia coli* – 95th Percentile

This classification reflects the overall water quality based on multiple samples taken weekly throughout the bathing season, not on single results. In all classified sites, the parametric limits for indicator bacteria are not exceeded. Classifications are excellent, good, sufficient and poor respectively as stipulated in the Bathing Water Directive. Poor rating indicates consistent higher than normal results, which are close to threshold limits (not an exceedance). At the start of the season, poor classifications may be more common due to the limited number of samples available at that stage.

Bathing is only NOT recommended in CLOSED sites.
